Answer “No” if you (1) have never engaged in active duty (including basic training) in the U.S. Armed Forces, (2) are currently an ROTC student or a cadet or midshipman at a service academy, (3) are a National Guard or Reserves enlistee activated only for state or training purposes, (4) were engaged in active duty in the U.S. Armed Forces but released under dishonorable conditions, and (5) if you are currently serving in the U.S. Armed Forces and will continue to serve through June 30, 2026.
